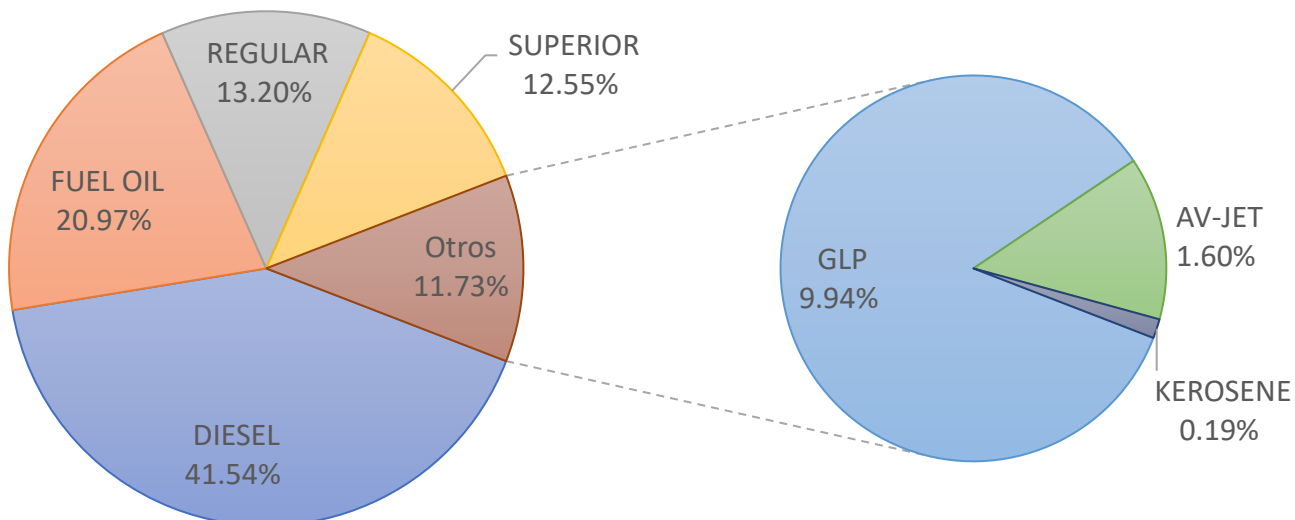

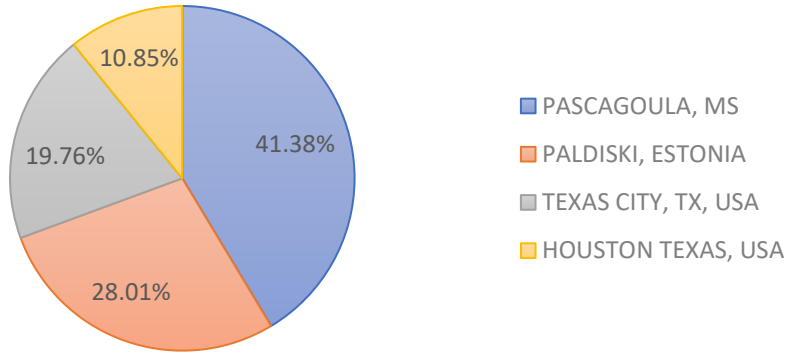
PORCENTAJE DE VOLUMEN IMPORTADO POR PRODUCTO



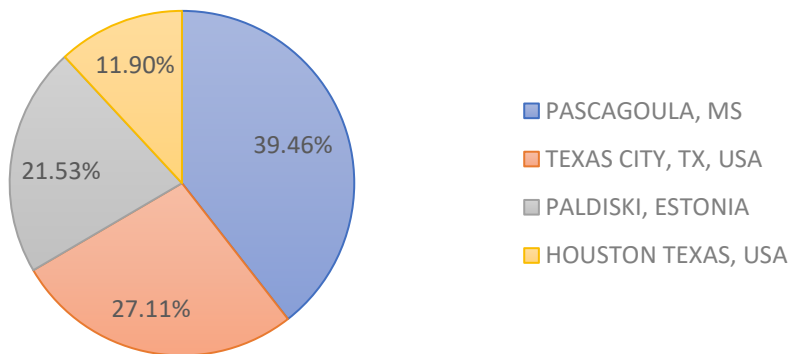
PORCENTAJE DE COSTO DE IMPORTACIONES CIF POR PRODUCTO



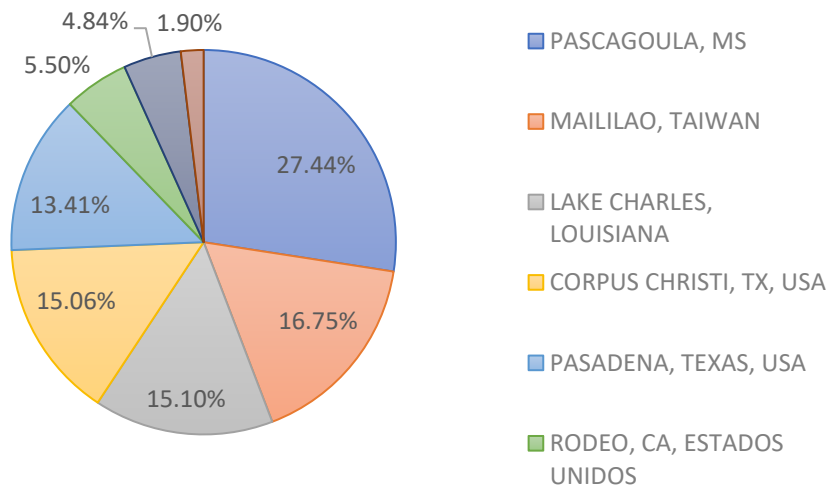
Procedencia de las Importaciones Gasolina Superior



Procedencia de las Importaciones Gasolina Regular



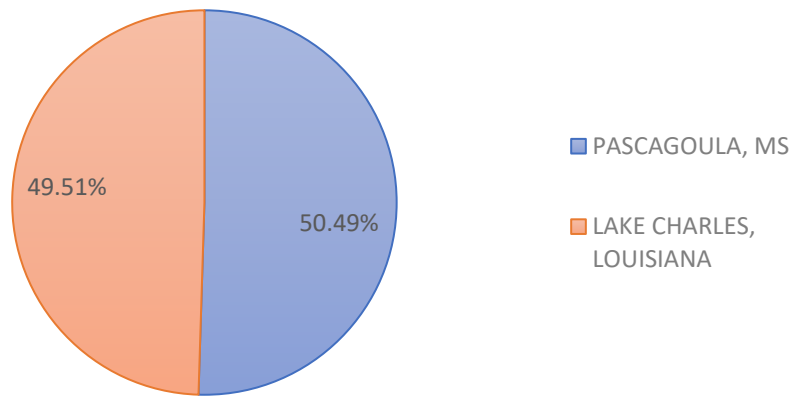
Procedencia de las Importaciones Diesel



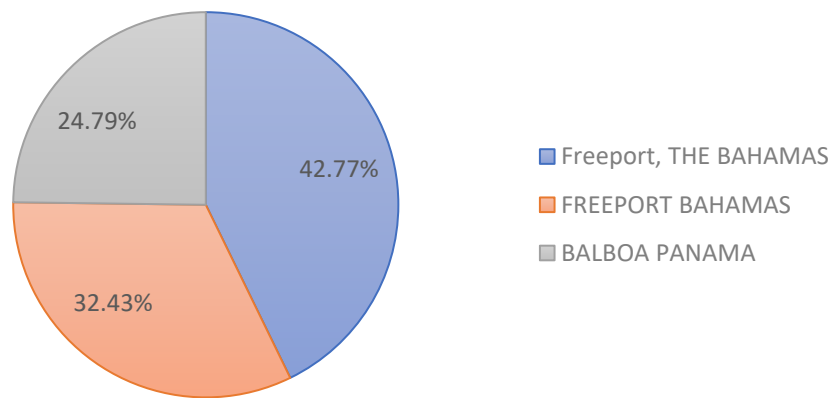

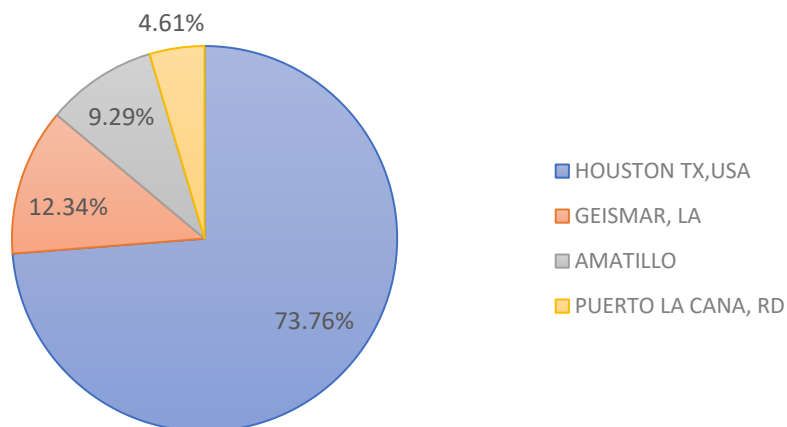
Procedencia de las Importaciones Kerosene



Procedencia de las Importaciones Fuel Oil



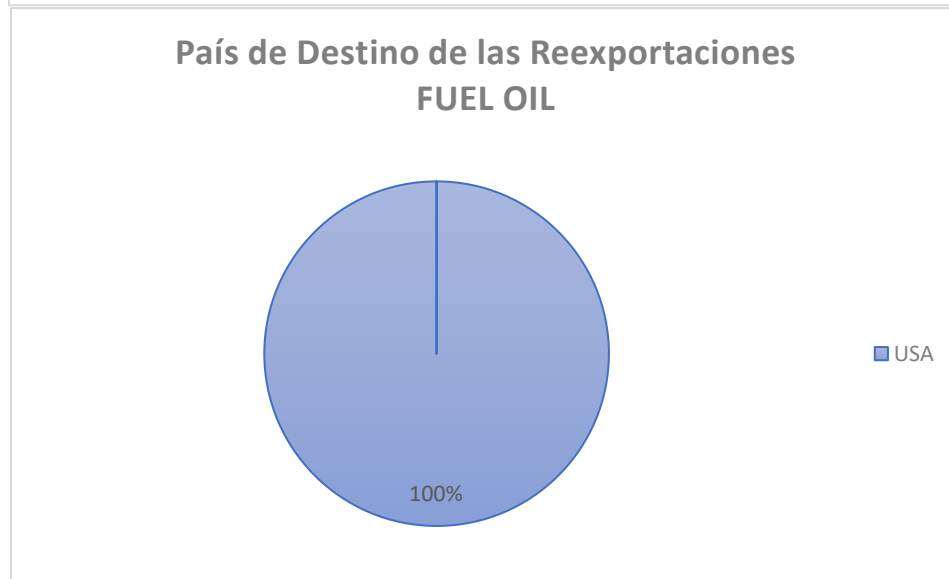
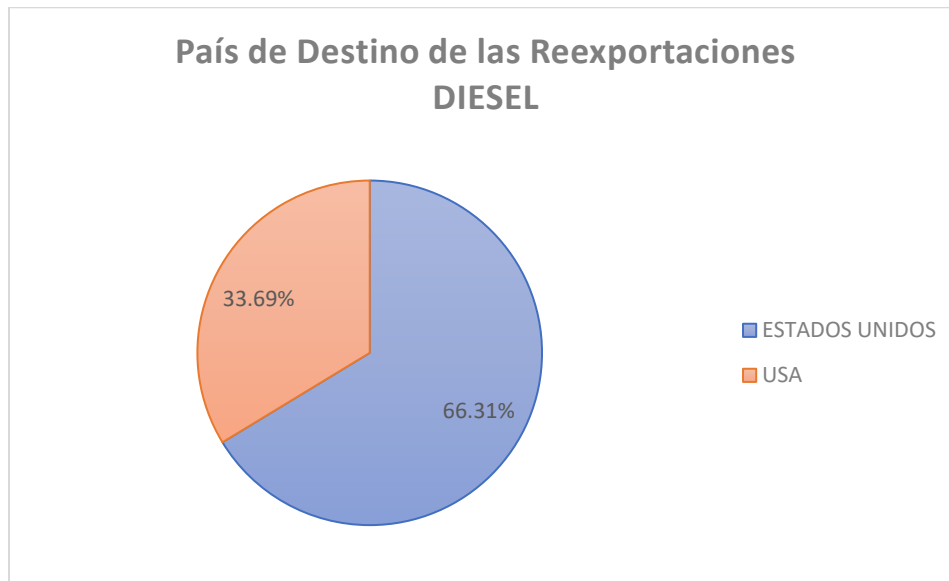

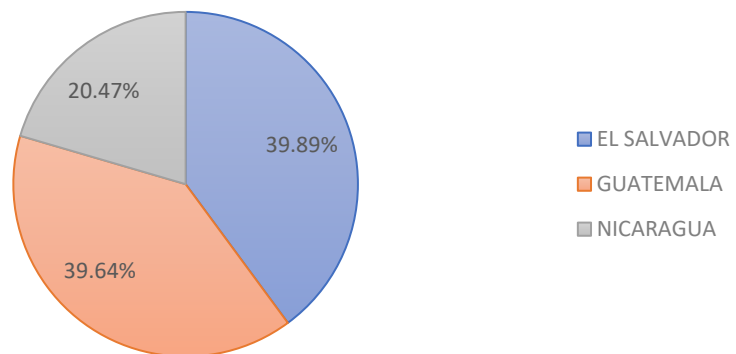

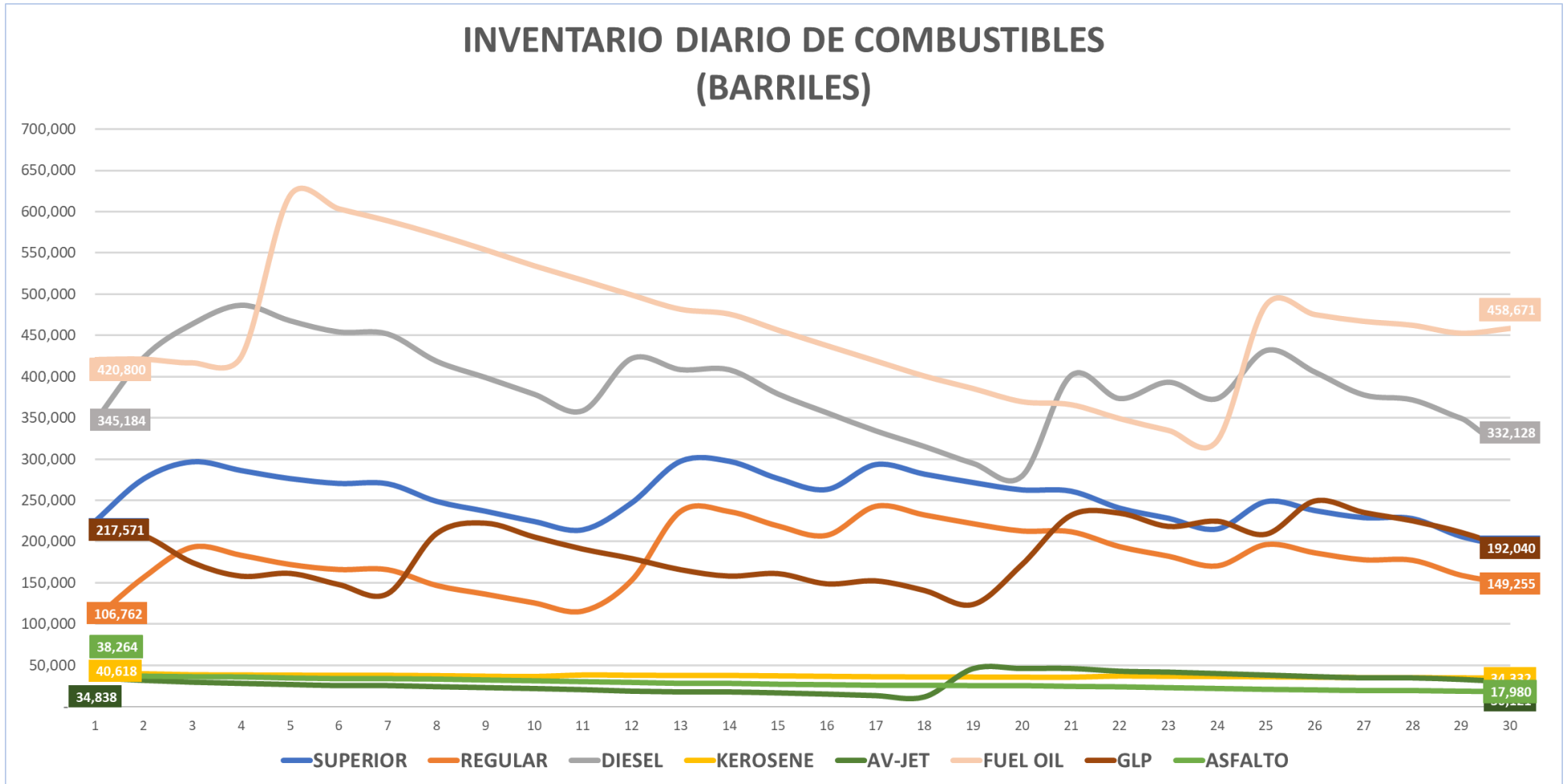

MOVIMIENTO DE INVENTARIO DIARIO



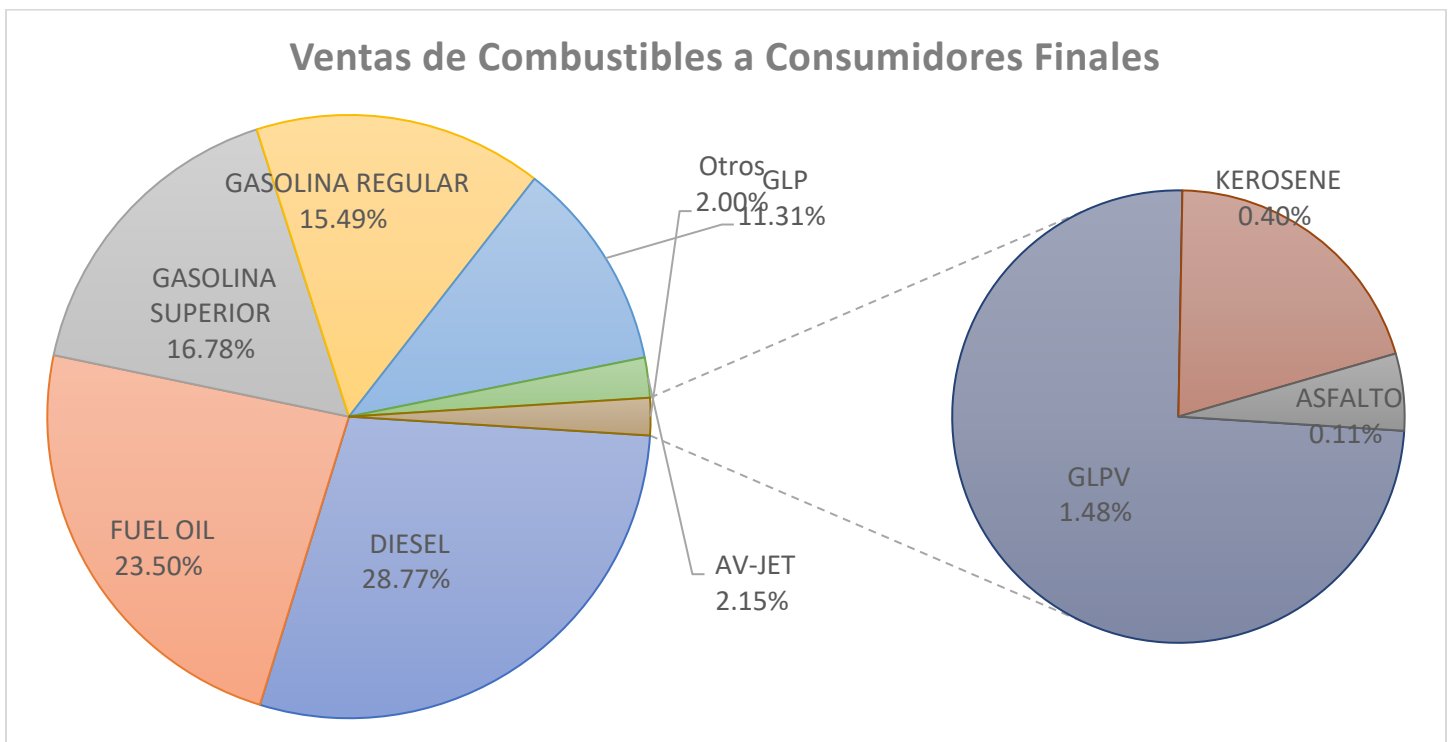

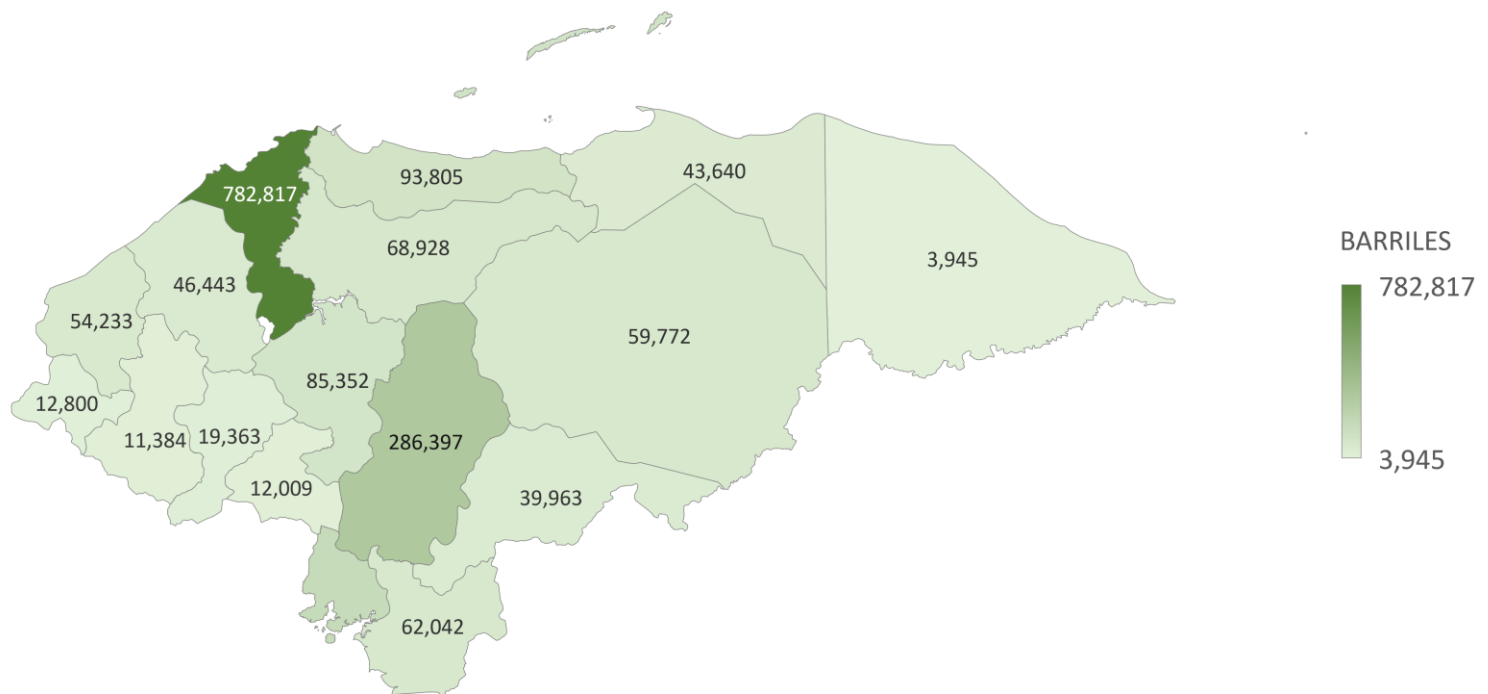

VENTAS DE COMBUSTIBLES A CONSUMIDORES FINALES



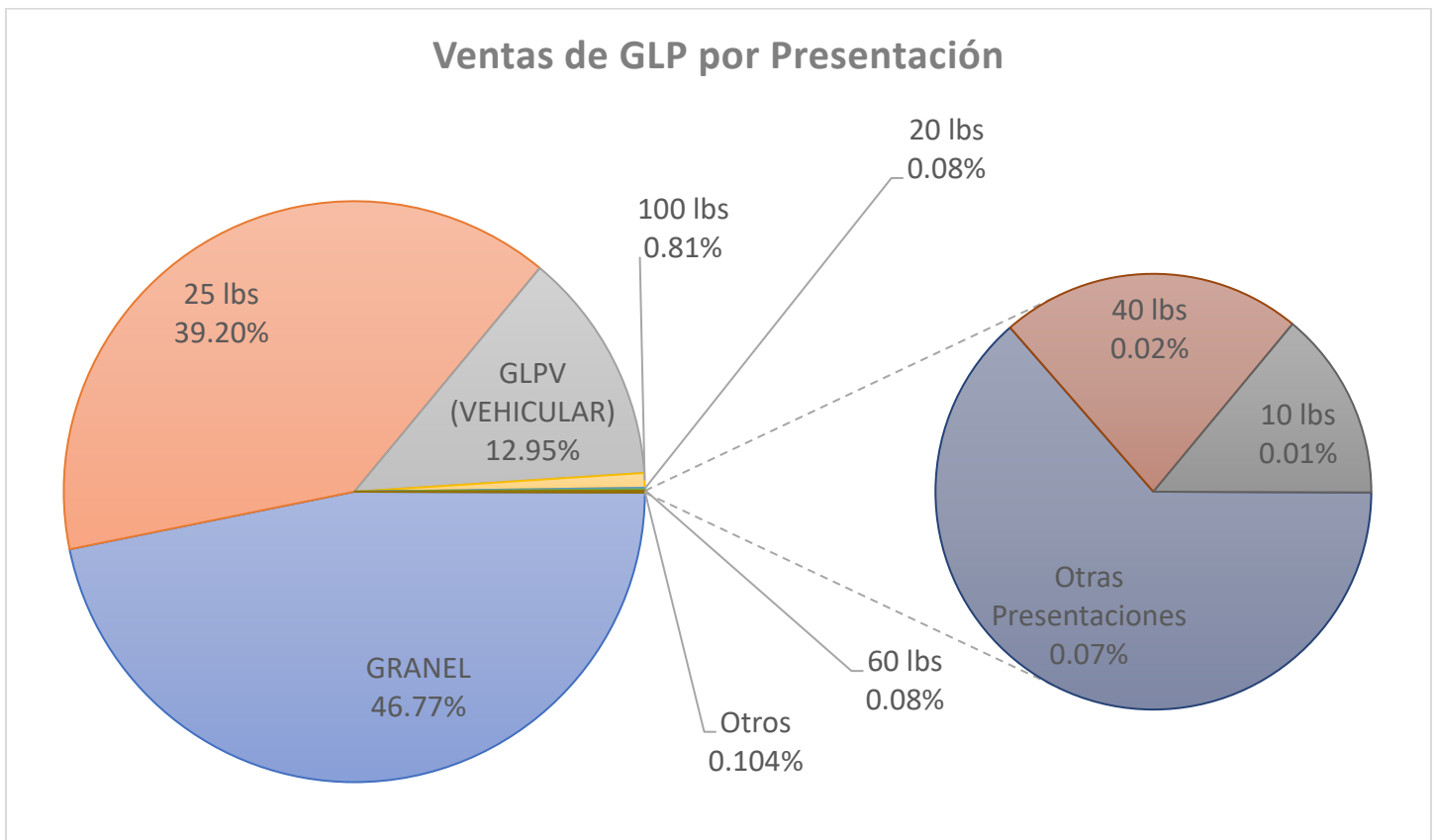

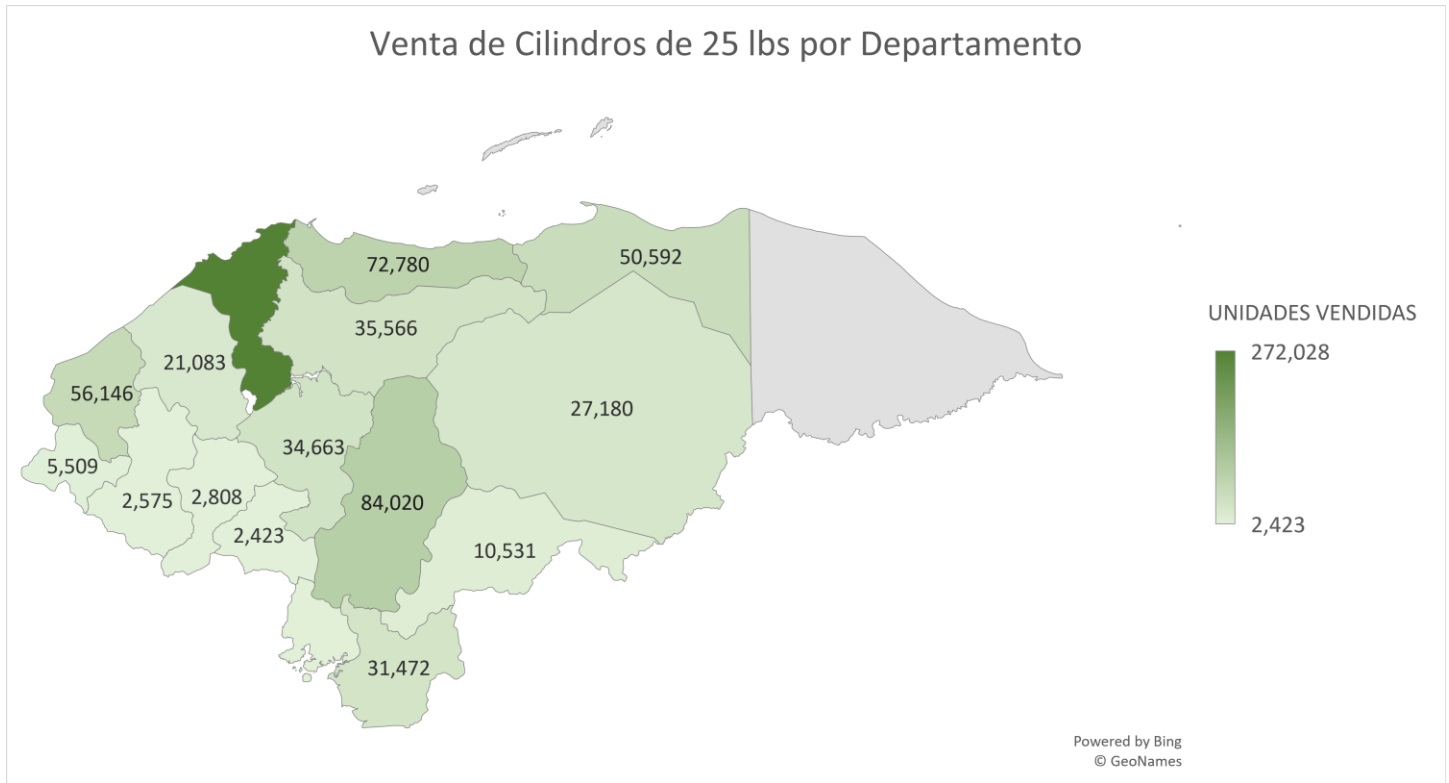
